We recall that the duration of the seal is irrelevant for the purposes of EPREL (it should only be valid when performing the electronic verification process). Only one seal is required for the verification of the organisation. No seal is required for registering models, afterwards.

The preferred "identity type reference" is "NTR" (i.e. a seal including the number of the registration in the national trade/business register) using the syntax of the EUID as defined in Regulation (EU) 2021/1042.
